This is in addition to the provisions of Deccan (now Telangana) Grameena Bank (officers and employees) service Regulations 2010, Chapter-II, Regulation No. 10.

Steps to be followed by the candidates:

Step 1: All the candidates shall be reported at S.L. Diagnostics, Nallakunta, Hyderabad by 7:00 A.M. sharp, on respective scheduled dates with EMPTY STOMACH / FASTING STOMACH for completion of medical tests.

Step 2: After completion of all medical tests at S.L. diagnostics, Nallakunta candidates shall report at Telangana Grameena Bank, Head Office, 3rd floor, Vijayasrisai Celestia, Nallakunta, Hyderabad-500044 (opposite to S.L.Diagnostics) on same day for Image Verification/ Authentication and Document Verification.

Step 3: After completion of document verification, candidate shall report to the Bank Medical Officer at Dispensary, SBI LHO, Bank Street, Koti, Hyderabad by 3:30 P.M. on same day for medical fitness examination.

Note: Above steps should be followed in the prescribed order only, any deviation will not be entertained.
